'National Trust' Competition terms and conditions

These are the terms and conditions for the National Trust Family Membership competition launched on Friday 4th September 2020 by Complete Childcare.

1. The promoter is Complete Childcare which is the group name for the entities Complete Childcare Ltd, Kingsclere Nurseries Ltd, Yellow Brick House Ltd, Yellow Brick Nursery Ltd.
2. By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
3. Any employees of Kingsclere Nurseries Ltd and their spouse/partners are not able to enter the competition.
4. Only parents or carers of children who are actively enrolled at a Complete Childcare nursery may enter this competition.  - c. Like and follow the Complete Childcare Nurseries page

10. The competition winner will be picked at random using number selector software.
11. The winner will be announced on the Complete Childcare Facebook page on 7th September 2020 and the winner will be contacted by email on the same day.

12. If we do not receive a response back to said email within 28 days of it being sent, or any response to any attempts we make to contact the winner, we reserve the right to withdraw the prize and pick a replacement winner.
